Phase 1 Delivery

Coronavirus has delayed the start of our in-community activity on Warm & Safe Homes in Fishwick but with our specialist partners appointed, we are now in a position to start to undertake some property surveys in a phased programme. It is very important to note at this point that any activity carried out will be fully compliant with current Government restrictions and guidelines on Coronavirus. Householders who are shielding and/or isolating will be given every opportunity to participate in the project at a later date when it is safe for them to do so.

If we contact you to arrange a property survey, we will explain everything about the process in detail and will confirm in a letter. Do be reassured that anyone who has expressed an interest in a property survey but, due to the Coronavirus situation, does not wish to have their survey carried out at present can defer their survey until the situation has improved. Just let us know if you are contacted by us. If you've returned your questionnaire to us but we don't get in touch with you immediately, don't worry we're delivering the project in a number of phases and you'll be contacted a little later.

The WASH in Fishwick Project Team were delighted the first week in January 2021 to contact three households who have been selected as our prize draw winners as a thank you for completing the survey last year. Shopping vouchers of £100, £50 and £25 are now in the post. If you have not yet completed a survey and would like to do so, it's not too late. If you have the questionnaire handy, please fill it in and send it to us in the envelope we provided. You don't need a stamp. 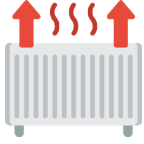

OTHER WORK IN THE COMMUNITY

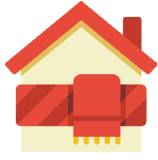
Jo has been busy engaging with the local foodbanks, sharing our Warm and Safe at Home (WASH) leaflets in the area to community centres, schools and faith groups. WASH offers free energy bill and benefits or income advice, including free fuel vouchers for those using a prepayment meter who are struggling with their energy bills. It's important to us that local residents know that we can provide help more broadly to assist householders with their energy use as well as income maximisation.

KEEPING WARM AT HOME IN WINTER

In October's newsletter, we focused on cutting down on your energy use. Now that we're in the middle of the winter months, we would like to give you some tips about how to stay warmer at home by thinking of some simple changes to your energy behaviour:



If you have a central heating system you should always use this to heat your home instead of electric or gas portable room heaters. These are likely to be much more expensive to run and, if controlled properly via the controller, a thermostat and TRVs in each room, the central heating is far more cost effective. An electric heater left on all day can cost up to £10 per day to use depending on the setting used.



Well-insulated homes retain heat, and cool more slowly which means you don't need the heating on for so long. In a typical uninsulated semi-detached property 35% of heat is lost through walls, 25% through the roof, 15% through the floors, 15% through draughts and 10% through windows.

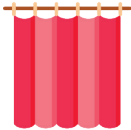


If you rent your home then your landlord (whether they're a company, housing association or a private individual) must carry out a safety check on all gas appliances once a year. For more information on carbon monoxide risks see

Preventing draughts can be a cheap way of making your home warmer. Simple draught-proofing products are available at DIY stores at reasonable prices.



Close your curtains at dusk to keep the heat in, do not cover your radiators and use thermal underlay beneath carpets to minimise heat-loss.

Remember that once energy efficiency measures have been done, they will carry on saving you money in years to come.
