- Reached **25,000** people and over **12,000** given in-depth advice
- Nearly 5,000 benefit checks, unlocking over £4 million in unclaimed income - an average of over £4,000 per client supported with a claim, more than twice the average energy bill

## Fuel Poverty Awareness Day

National Energy Action's awareness day trended on social media and we held an event with MPs



Wednesday 26 November was our Fuel Poverty Awareness Day, a day for bringing organisations together to speak about the causes and solutions to fuel poverty.

We had a great response from organisations posting online. Thank you to all partners who got involved and supported on their social media.

On X (formerly known as

Twitter) alone, the hashtag reached over 5 million accounts and it was 'trending' at 20th in the UK, even as Senedd (MSs) recorded videos to the Budget was taking place, which shows what an important issue fuel poverty remains.

The day before, many MPs attended our Parliamentary event to find out more. These included Martin McCluskey, Minister for Energy Consumers, and many other elected officials.

In Wales, several Members of the show their support for the day. It was mentioned on several occasions in Plenary in the Senedd, and we held a Cross-Party Group meeting with the Cabinet Secretary for Housing and Local Government, three MSs and over 50 members in attendance.

## Working with partners to help parents: Chloe's story

A single parent in tough circumstances sees a brilliant outcome from after being referred to National Energy Action

Chloe is a single parent living in a local authority rented property with two children aged three and six. Chloe is a student and has poor mental health and her son is undergoing an assessment for autism.

Chloe was referred to National

Energy Action after she had moved house because of harassment from her children's father, and this left her struggling with paying an £800 debt with her energy supplier, water debts and rent arrears.

Parents are a demographic that are



particularly likely to be worried about energy. A recent YouGov poll for National Energy Action found that:

- 68% of parents with children under 16 reported being worried about energy costs this winter.
- One in five parents expect to go into debt this winter to pay their energy bill.

National Energy Action arranged a three-way call with Chloe's energy supplier to sort out meter readings and a debt repayment plan for her previous property.

National Energy Action helped Chloe with energy advice, a Winter Warmth Support Pack, an air fryer, and a heated clothes airer. She had been

taking laundry to a local launderette.

Chloe was also provided with information about how to apply for a water social tariff and was referred to a local service provider for a benefit check and debt advice.

Chloe was also helped to make an application to The Children in Need Family Fund to replace her broken cooker and referred to Better Housing Better Health for a home visit to explore other energy saving measures.

National Energy Action's interventions, and work with partners, helped Chloe to heat her home, use her appliances more efficiently, increased her confidence

communicating with her energy supplier and helped her seek debt advice.

'Thank you so much with all the help you have given to me, I really appreciate this,' she said.

'I have received my air fryer and heated airer, I just want to say thank you so much for your help you have been amazing!'

## Gas appliance servicing

Make the most of free gas appliance servicing for households in need this winter



Our Warm Homes, Healthy
Futures programme can offer
free gas appliance servicing for
eligible clients.

Eligibility is simple. Clients must:

- Have a health condition or disability
- Be responsible for the gas
   appliance and not had it serviced
   in the last 12 months (can include cookers in social and private rented properties)

 Be in receipt of a means-tested benefit

Unsafe or poorly maintained gas cooking and heating appliances can put households at risk of carbon monoxide poisoning, gas leaks and fires. Many find it difficult to service their appliances due to the cost or awareness, exposing them to risk of dangerous faults and breakdowns.

You can refer eligible households to National Energy Action's gas safety org.uk/whhf-servicing/ and they will receive a free safety service from a qualified engineer. If a fault is identified, we are currently able to cover the cost of repair or replacement.

The referral process is quick and easy, and there will be no cost to the householder. The referral could

protect a family's health, prevent breakdowns during the cold winter months, and critically reduce exposure to carbon monoxide risk.

On 20 and 21 November 2025, over 175 delegates gathered at the Golden Jubilee Conference Hotel in Clydebank for Energy Action Scotland's Annual Conference, united by the theme 'Energy Justice for Households in Scotland'.

Across two impactful days, Scotland's foremost experts, policy makers, and practitioners came together to share ideas and solutions commitment to a common vision: to tackle fuel poverty. Plenary sessions explored 'An Energy System across Scotland and ensuring that That Works for Everyone' and 'Ultra Vulnerability and Financial Exclusion',


while interactive workshops delved into 'EPC Reform', 'Tariffs and Network Flexibility', and the social impacts of austerity.
