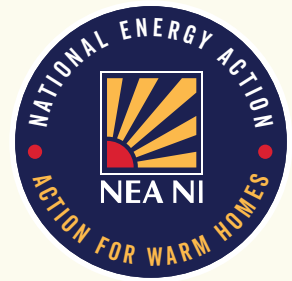


# Fuel Poverty in Ards and North Down



**In 2025, 39% of households in Northern Ireland were living in fuel poverty, spending more than 10% of their income on energy.**



The median energy rating score for dwellings assessed between April 2013 and March 2023 was **65 (EPC band D)**.



The estimated seasonal increase in mortality during winter 2024/25 was **70 additional deaths**.



Across 2022/23 – 2024/25, **11% of households were renting in the Private Rented Sector**.



The average rate of **relative poverty** after housing costs between 2021 and 2024 was **18%**.



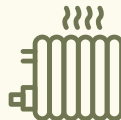
The **median weekly wage** in 2025 was **£506**.



In 2025, **9.2%** of the population were in receipt of **Universal Credit**, and **9.5%** were in receipt of **Personal Independence Payment**.



In 2024/25, **12.1%** of all **Northern Ireland Sustainable Energy Programme (NISEP)** measures were installed here.



At the Census 2021, **40%** of occupied households had **'oil only'** central heating and **47%** had **'mains gas only'**.

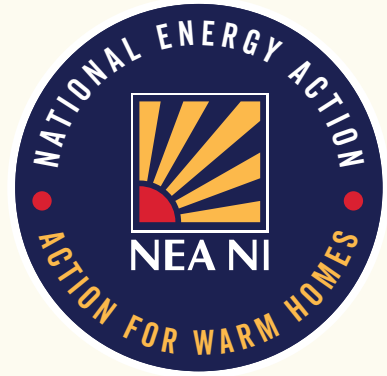


At the Census 2021, only **5%** of households had any **renewable energy systems**.

## Across Northern Ireland

- **Health and wellbeing:** LucidTalk polling for NEA NI in 2025 found that 1 in 4 households experienced health and wellbeing impacts, and 7% had cut back on food, due to rising energy prices and the cost of living.
- **Child fuel poverty:** Around 174,000 children are estimated to be living in fuel poverty (NEA).
- **Dying in fuel poverty:** Almost 1 in 3 people in their last year of life (27%) are estimated to be in fuel poverty (Marie Curie).
- **Reliance on home heating oil:** Around 61% of households use oil central heating as their primary heating method (Department for the Economy).
- **Fuel poverty target:** The NI Executive has a 10-year Warm Healthy Homes Strategy (2026-2036), but no statutory fuel poverty reduction target.

## Who we are

In Northern Ireland, we chair the **Fuel Poverty Coalition NI** and act as the secretariat to the **All-Party Group on Fuel Poverty**. We advocate for policy and regulatory reforms to protect the most vulnerable, and we deliver accredited training to improve standards in energy advice.

Through the **Belfast Warm and Well Project**, we provide advice and practical support to local people struggling to keep their homes warm.

## Key policy recommendations

**National Energy Action NI is calling on the NI Executive, Assembly, and local councils to:**

- Deliver the Executive's **Warm Healthy Homes Strategy** (2026–2036) to tackle fuel poverty in Northern Ireland.
- Support an ambitious, properly resourced **Warm Healthy Homes Fund**, that delivers energy efficiency investment at scale for low-income and vulnerable households, including households with children.
- Set **statutory fuel poverty targets** to drive long-term delivery and monitor progress.
- Establish **minimum energy efficiency standards** and extend **Awaab's Law protections** to all rented homes in Northern Ireland.
- Introduce an **energy social tariff** to provide discounted, targeted energy bill support to low-income and vulnerable households.
- Support a **just and affordable transition to net zero**, including fair allocation of decarbonisation costs.
- Introduce **regulatory oversight of the heating oil market**.
